

RESOLUTION NO. 19-5

**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A
CONTRACT WITH MODULAR CONNECTIONS, LLC FOR THE
CONSTRUCTION OF A TORNADO SAFE ROOM**

WHEREAS, the City of Pinson, Alabama received sealed bids for the Project:
City of Pinson Tornado Safe Room (the "Project");

WHEREAS, such bids included various alternate items and pricing;

WHEREAS, the City Council has reviewed the same, and finds that the lowest
responsible and responsive bidder for this project was Modular Connections, LLC, who
submitted a Total Base Bid in the amount of \$159,866;

WHEREAS, the City Council also determines that it wishes to accept Alternate 1,
Alternate 2, and Alternate 4B, which would result in an adjusted contract sum of
\$167,658, with respect to this same bidder;

WHEREAS, the City Council desires to award the contract for the Project, and to
authorize execution of the contract for construction.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF PINSON, ALABAMA** while in regular session on February 21, 2019 at
7:00 p.m., as follows:

1. The contract for the Project is hereby awarded to Modular Connections,
LLC, with respect to its Total Base Bid, Alternate #1, Alternate #2, and Alternate #4B
(for an adjusted contract sum of \$167,658).


2. The Mayor is directed to prepare a contract that is in conformity with the
bid specifications and proposal of the successful bidder, and to execute it in the name of,
and on behalf of, the City. Such contract, at the Mayor's reasonable discretion, may

include further and additional terms that accomplish the purpose of this Resolution, to the extent that the same are not inconsistent with the bid specifications and proposal of the successful bidder, and are otherwise permitted by law.

3. The Mayor is further authorized to carry out the terms of such contract(s) as soon as may be practicable, and to execute such other and additional documents that may be necessary and/or required in order to facilitate the transaction described herein.

4. The Mayor, on behalf of the City, is further authorized to obtain, order, and direct the installation/expenditure of additional items such as utility connections, paving, and any other item not included in the base contract but reasonably required to fulfill the intent of this Resolution and to provide for efficient completion of the Project.
