Committee Chair Reports:

<u>Finance:</u> Councilor Irvin offered a motion to pay the bills in the amount of \$64,228.55. Councilor Roberts duly seconded the motion. Highlights on the bills included \$34,000 to the Jefferson County Sherriff's Office. Mayor Cochran called for all in favor say 'aye', all opposed say 'no'. Mayor Cochran, "let the record reflect the 'ayes' carry unanimously."

Mayor's Report: Mayor Cochran announced the Library will be closed all day on December 16, 2022, for employee training as well as all other city facilities, closing at 11:00 a.m.

Old Business: Councilor Walker offered a motion to accept a bid for janitorial services in the amount of \$4,182 a month. Councilor Walker mentioned the janitorial services will be for the Palmerdale Homestead Community Center, Rock School Complex, Library, City Hall, and the Pinson Community Center. Councilor Kirkland duly seconded the motion. Mayor Cochran called for a roll call vote with the following results: Councilor Irvin-yes, Councilor Walker-yes, Councilor Roberts-yes, Councilor Churchwell-yes, Councilor Kirkland-yes, Mayor Cochran-yes. Mayor Cochran, "let the record reflect that passes unanimously."

Councilor Kirkland offered a Resolution to create the Operation Director position. Councilor Walker duly seconded the motion. Councilor Roberts mentioned that the current Public Works Director, Eric Winfrey, will modify his current position to take on the Operation Director position. Mayor Cochran called for a roll call vote with the following results: Councilor Irvin-

yes, Councilor Walker- yes, Councilor Roberts- yes, Councilor Churchwell- yes, Councilor Kirkland- yes, Mayor Cochran- yes. **Mayor Cochran**, "let the record reflect that passes as Resolution 22-36."

Councilor Roberts offered a motion to approve the increase of salary for the Operation Director by \$5,000 per year. Councilor Churchwell duly seconded the motion. Mayor Cochran called for all in favor say 'aye', all opposed say 'no'. Mayor Cochran, "let the record reflect the 'ayes' carry unanimously."

Public Comment: Mayor Cochran opened the floor for public comment.

Seeing none, Mayor Cochran called for a motion to adjourn.
