AN ORDINANCE CONCERNING A FRANCHISE WITH CRC COMMUNICATIONS LLC

WHEREAS, Otelco, Inc. is a telecommunications company offering fiber and internet services, and CRC Communications LLC ("CRC") is its competitive fiber subsidiary;

WHEREAS, CRC has requested a franchise from the City of Pinson, so that it may operate within the public ways of the City;

WHEREAS, the City Council desires to extend a non-exclusive franchise to CRC.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PINSON, ALABAMA, while in regular session on Thursday, April 7, 2022, at 7:00 p.m., as follows:

- 1. The City hereby grants a nonexclusive franchise to occupy or use the public ways to provide telecommunications services to CRC, as set forth in more detail in that certain Franchise Agreement, set forth hereto as *Attachment A*. The Mayor is authorized, for and on behalf of the City, to execute the Franchise Agreement, in substantially the same form as shown.
- 2. The Mayor is authorized to take actions and execute such other and further documents as may be necessary to effect and carry out the transaction contemplated by this Ordinance.
