

RESOLUTION NO. 19-41

**A RESOLUTION CONCERNING THE DIRECTOR  
OF PUBLIC SAFETY**

---

**WHEREAS**, Bob Jones is the Zoning Official of the City of Pinson, Alabama;

**WHEREAS**, the position of Zoning Official was established by the City Council of the City of Pinson, Alabama in 2011;

**WHEREAS**, as the City's municipal governmental operations have grown, the Zoning Official's activities have changed;

**WHEREAS**, the City wishes to modify and restate the position of Zoning Official as stated herein, including re-naming that position as the Director of Public Safety; and

**WHEREAS**, the City Council commends Bob Jones for the work that he does in this position.

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PINSON, ALABAMA** while in regular session on December 19, 2019 at 1:00 p.m. as follows:

1. The job description for the position of Zoning Official, including the rate of pay, is amended and modified so that it reads as shown in Exhibit A to this Resolution.
2. The job position formerly known as the Zoning Official shall now be known as the Director of Public Safety.
3. The Director of Public Safety shall report to the Mayor, who supervises and controls the affairs of the City pursuant to state law. The Mayor shall supervise the

activities of the Director of Public Safety and make all employment decisions relating thereto.

4. Upon a vacancy in this position, the Mayor is authorized and directed to employ an individual to fill the position of Director of Public Safety.

5. The Director of Public Safety position is a full-time position.


6. The Director of Public Safety shall be an at-will employee of the City of Pinson, not a municipal officer, and said employment may be terminated at any time.

7. The Director of Public Safety shall be a law enforcement officer. To that end, the City does hereby vest in the Director of Public Safety, to the extent allowed by law, the police powers of the City which are necessary to enforce the ordinances of the City, to make arrests incident to the enforcement thereof, and to do such other things and perform such other acts as are necessary with respect thereto.

8. Resolution No. 11-26 is hereby replaced and superseded by this Resolution.


